NC Innovations is authorized by a Medicaid Home and Community-Based Services (HCBS) Waiver granted by the Centers for Medicare and Medicaid Services (CMS) under Section 1915 (C) of the Social Security Act.

NC Innovations Waiver is designed to provide an array of community based services and supports to promote choice, control and community membership. These services provide a community-based alternative to institutional care for persons who require an ICF-MR level of care and meet additional eligibility criteria for this waiver.

GOALS OF THE WAIVER?

To value and support waiver participants to be fully functioning members of their community.

To promote promising practices that result in real life outcomes for participants.

To offer service options that will facilitate each participant's ability to live in homes of their choice, have employment or engage in a purposeful day of their choice, have employment or engage in a purposeful day of their choice and achieve life goals.

To provide the opportunity for all participants to direct their services to the extent they choose.

To provide educational opportunities and support to foster the development of stronger natural support networks and enable participants to be less reliant on formal support systems.
